What changed with SB37:

<u>Defined private practice</u>

Added courses to academic standards:

For MFTs: crisis or trauma, grief or loss, social/cultural foundations

For CPCs: human sexuality, couples counseling, family systems, crisis or trauma, grief or loss. Graduates from COAMFTE or CACREP accredited programs are considered to have fulfilled the NRS educational requirements for licensure as an intern.

<u>Intern Application Process Streamlined:</u> Letters of reference are no longer required. Personal interviews are no longer required for all licensees, only required on a case-by-case basis.

<u>More flexible national exam process:</u> MFTs and CPCs now can take their exams 3 times in 1 year if needed. MFTs now have same ability as CPCs to take national exam during their final semester of graduate study.

<u>Supervisor Accountability Increased:</u> Supervisors must meet with primary supervisees at least 1 hour per week with documentation.

<u>Supervisor Capacity Expanded:</u> The cap for supervisors of primary supervisees has been increased from 6 to 10. The three-year residency requirement for living in Nevada has been eliminated. Other allied mental health professionals (psychologists, psychiatrists, and social workers) will be approved as secondary providers in extenuating circumstances and/or upon the recommendation of an intern's primary supervisor.

<u>CEU Options Broadened and Clarified:</u> CEU credits may be earned for teaching and taking graduate-level coursework. Credits may now be earned by attending MFT/CPC BOE meetings or attending meetings or events of coalitions, committees, or boards related to community health care. If you can document your attendance and write up what you learned, you can submit it to the board for credit. MFTs and CPCs are now able to earn all CEUs online if interactive and live. Otherwise, there is a 10 hour limit on CEUs earned trough non-interactive and non-live platforms.

<u>Professional responsibility Augmented:</u> Telehealth ethics are now part of regulatory code. Increased documentation protection for Couple/Family/Group treatment.

CPC Practice Scope Restriction rescinded: All CPCs have the practice scope listed in NRS 641A.065

The Board of Examiners has submitted a BDR to the legislature for consideration in the 2019 session. SB 37 will be introduced into the Senate's Commerce and Labor committee. Expansion of scope to include psychotic disorder treatment. Fee additions and increases. Two-year license. Internships don't terminate upon supervisor change.
